Instead, you should've received an approval letter from the DOR in the mail. If you received an SSO1 tax credit receipt from Apogee, that is evidence enough that you were approved.

Georgia Credit Carryforwards

In Georgia, most credits are limited to your tax liability and they are not refundable.

If you are not able to take the full amount of your credit in a previous year, you may be able to take the credit in later years until you use it up or time runs out.
